PUBLICAÇÕES: Relatório Anual da Administração, Demonstrações Financeiras relativas ao exercício social findo em 31/12/2018 acompanhadas das Notas Explicativas, Parecer da EY Auditores Independentes e Relatório do Comitê de Auditoria publicados, em 22/2/2019, no jornal Valor Econômico (fls. C9 a C13) e no Diário Oficial do Estado de São Paulo (fls. 102 a 114).

PRESENÇA: Presentes acionistas representando mais de 59% (cinquenta e nove por cento) do capital social votante e total da Companhia, conforme se verifica (i) pelas assinaturas no “Livro de Presença de Acionistas”, respeitado no cômputo dos votos a regra do artigo 7º do Estatuto Social; e (ii) pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia ou diretamente pela Companhia, nos termos da regulamentação da CVM. Em razão do quórum verificado, o Presidente deu por instalada a Assembleia Geral Ordinária e a Assembleia Geral Extraordinária, sendo esta última para deliberar sobre as propostas de alteração do Plano de Concessão de Ações, e esclareceu aos presentes que, não havendo quórum suficiente para a instalação da Assembleia Geral Extraordinária para deliberar sobre as propostas de alteração do estatuto social, será publicado novo edital de convocação para que se delibere, em segunda convocação, sobre a referida matéria constante na Ordem do Dia, nos termos do artigo 12, parágrafo 6º do Estatuto Social da Companhia. Presentes, ainda, integrantes da Administração da Companhia e os Srs. Gregory Gobetti e Emerson Morelli, representantes da EY Auditores Independentes.

ORDEM DO DIA: I – Em Assembleia Geral Ordinária: (1) Aprovar as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2018; (2) Deliberar sobre a destinação do lucro líquido do exercício social encerrado em 31/12/2018; (3) Deliberar sobre a quantidade de membros que comporão o Conselho de Administração; (4) Eleger os membros do Conselho de Administração da Companhia; (5) Ratificar a remuneração global efetivamente paga à Diretoria no exercício de 2018; (6) Aprovar a remuneração global dos membros do Conselho de Administração para o exercício de 2019, incluindo, na forma determinada pela CVM, a melhor estimativa do valor dos encargos; (7) Aprovar a remuneração global dos membros da Diretoria para o exercício de 2019, incluindo, na forma determinada pela CVM, a melhor estimativa do valor dos encargos; (8) Uma vez instalado o Conselho Fiscal, eleger os seus respectivos membros; e (9) Uma vez instalado o

Conselho Fiscal, fixar a sua remuneração nos termos da legislação societária. **II – Em Assembleia Geral Extraordinária:** (1) Deliberar sobre as seguintes alterações do Estatuto Social da B3, conforme detalhadas com marcas de revisão na Proposta da Administração: (a) alterar a expressão do capital social da Companhia de sorte a refletir o aumento aprovado pelo Conselho de Administração em reunião realizada em 14/12/2018; (b) modificar atribuições dos órgãos da administração de modo a otimizar os processos decisórios e de governança da Companhia; (c) simplificar a redação dos dispositivos estatutários, inclusive eliminando conteúdo meramente replicado da legislação e da regulamentação em vigor; (d) ajustar a redação do artigo 76, §1º, ao Parecer de Orientação CVM nº 38; (e) excluir a disposição transitória prevista no artigo 79, dado o término do respectivo prazo de vigência; (f) outros ajustes de terminologia, redação, referência cruzada e renumeração; e (g) consolidar tais propostas de alteração estatutária e aquelas aprovadas na Assembleia Geral Extraordinária realizada em 4/5/2018; e (2) Deliberar sobre as propostas de alteração do Plano de Concessão de Ações da Companhia.

DELIBERAÇÕES: Dispensada a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, consoante o parágrafo 4º do art. 21-W da Instrução CVM nº 481/2009, foram tomadas, com a abstenção dos legalmente impedidos, as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei nº 6.404/76:

I – Em Assembleia Geral Ordinária:

(1) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.080.922.576 votos a favor, e 206.768.164 abstenções, sem reservas, as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2018, acompanhadas das Notas Explicativas, Parecer da EY Auditores Independentes e Relatório do Comitê de Auditoria, registrada a abstenção dos administradores nesse item.

(2) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.217.083.099 votos a favor, e 70.607.641 abstenções, a proposta de destinação do lucro líquido do exercício social encerrado em 31/12/2018, correspondente a R\$2.087.444.014,82 nos seguintes termos:

(i) R\$1.434.999.512,28 à conta de dividendos obrigatórios, montante este que já foi integralmente pago aos acionistas por meio de juros sobre capital próprio durante o exercício de 2018; e

(ii) R\$652.444.502,54 para constituição da reserva estatutária para investimentos e composição dos fundos e mecanismos de salvaguarda da Companhia.

(3) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.217.850.946 votos a favor, e 69.839.794 abstenções, que o Conselho de Administração seja composto por 11 membros.

(4) Aprovar, por maioria dos acionistas presentes, tendo sido computados 1.196.414.817 votos a favor, 7.333.186 votos contrários; e 83.942.737 abstenções, a eleição, nos termos do Estatuto Social, das pessoas a seguir indicadas para comporem o Conselho de Administração da Companhia, para mandato até a Assembleia Geral Ordinária que aprovar as demonstrações financeiras do exercício a se encerrar em 31/12/2020: (i) como Membros do Conselho de Administração, os Srs. **CASSIANO RICARDO SCARPELLI**, brasileiro, casado,

(5) Ratificar, por maioria dos acionistas presentes, tendo sido computados de 1.183.717.571 votos a favor, 740.455 votos contrários; e 103.232.714 abstenções, os pagamentos feitos à Diretoria no exercício de 2018 no valor de R\$ 52.223.760,10, conforme Proposta da Administração.

(6) Aprovar, por maioria dos acionistas presentes, tendo sido computados 1.115.923.947 votos a favor, 91.309.011 votos contrários; e 80.457.782 abstenções, a fixação da remuneração global anual do Conselho de Administração para o corrente exercício, no valor de até R\$ 18.204 mil, nos termos da Proposta da Administração.

(7) Aprovar, por maioria dos acionistas presentes, tendo sido computados 1.121.021.161 votos a favor, 76.454.432 de votos contrários; e 90.215.147 abstenções, a fixação da remuneração global anual da Diretoria para o corrente exercício, no valor de até R\$ 81.502 mil, nos termos da Proposta da Administração.
