CONVOCAÇÃO: Edital de convocação publicado nos dias 1, 2 e 3 de abril de 2020 no Diário Oficial do Estado de São Paulo (fls. 88, 61 e 100, respectivamente) e no jornal Valor Econômico (fls. C09, C03 e C03, respectivamente).

PUBLICAÇÕES: Relatório Anual da Administração, Demonstrações Financeiras relativas ao exercício social findo em 31/12/2019 acompanhadas das Notas Explicativas, Parecer da EY Auditores Independentes e Relatório do Comitê de Auditoria publicados, em 06/03/2020, no jornal Valor Econômico (fls. C09 a C14) e no Diário Oficial do Estado de São Paulo (fls. 128 a 140).

PRESENÇA: Presentes acionistas representando mais de 67% (sessenta e sete por cento) do capital social votante e total da Companhia, conforme se verifica (i) pelas assinaturas no “Livro de Presença de Acionistas”, (ii) pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia ou diretamente pela Companhia, nos termos da regulamentação da CVM e (iii) pelas presenças registradas no sistema eletrônico de participação à distância disponibilizado pela Companhia, nos termos do art. 21-V, inciso III, da ICVM 481, respeitado no cômputo dos votos a regra do artigo 7º do Estatuto Social. Em razão do quórum verificado, o Presidente deu por instalada a Assembleia Geral Ordinária e a Assembleia Geral Extraordinária. Presentes, ainda, integrantes da Administração da Companhia, e o Sr. Flávio Serpejante Peppe, representante da EY Auditores Independentes, além do Coordenador do Comitê de Auditoria e do Coordenador do Conselho Fiscal, estes dois últimos por meio do sistema eletrônico de participação à distância nos termos do art. 21-C, §5º, da ICVM 481.

ORDEM DO DIA: I – Em Assembleia Geral Ordinária: (1) Aprovar as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2019; (2) Deliberar sobre a destinação do lucro líquido do exercício social encerrado em 31/12/2019; (3) Aprovar a remuneração global dos administradores para o exercício de 2020, bem como os decorrentes encargos e suas eventuais variações positivas; e (4) Na hipótese de haver pedido válido de instalação do Conselho Fiscal, eleger os respectivos membros e fixar a sua remuneração. **II – Em Assembleia Geral Extraordinária:** (1) Deliberar sobre as seguintes alterações do Estatuto Social da B3, conforme detalhadas na Proposta da Administração: (a)

alterar a expressão do capital social da Companhia, conforme deliberação do Conselho de Administração em reunião realizada em 05/03/2020; (b) ajustar a redação do objeto social, de modo a prever mais expressamente algumas atividades já abrangidas pelo objeto social atual; (c) alterar o prazo máximo para exercício do cargo de membro do Comitê de Auditoria que também seja membro do Conselho de Administração; (d) excluir a disposição transitória prevista no artigo 79, dado que não restaram membros no Comitê de Auditoria que atendam à disposição transitória; (e) outros ajustes de redação, referência cruzada e renumeração; e (f) consolidar tais propostas de alteração estatutária no Estatuto Social vigente.

DELIBERAÇÕES: Dispensada a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, consoante o parágrafo 4º do art. 21-W da Instrução CVM nº 481/2009, foram tomadas, com a abstenção dos legalmente impedidos, as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei nº 6.404/76:

(1) Aprovar, por maioria dos acionistas presentes, tendo sido computados 1.033.328.812 de votos a favor, 533.600 de votos contrários; e 328.285.137 abstenções, sem reservas, as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2019, acompanhadas das Notas Explicativas, do Parecer da EY Auditores Independentes, do Relatório do Comitê de Auditoria e do Parecer do Conselho Fiscal, registrada a abstenção dos administradores nesse item.

(2) Aprovar, por maioria dos acionistas presentes, tendo sido computados 1.168.627.936 de votos a favor, 26.765 de votos contrários; e 193.492.848 abstenções, a proposta de destinação do lucro líquido do exercício social encerrado em 31/12/2019, correspondente a R\$ 2.714.164.629,20, integralmente destinado à conta de dividendos obrigatórios, montante este que já foi pago aos acionistas a título de dividendos e juros sobre capital próprio, considerando que o montante contabilizado na reserva legal já atinge o limite previsto pela legislação.

(3) Aprovar, por maioria dos acionistas presentes, tendo sido computados 921.417.764 de votos a favor, 233.731.465 de votos contrários; e 206.998.320 abstenções, a fixação da remuneração global anual dos administradores da Companhia, para o corrente exercício, no valor de até R\$98.986 mil, nos termos da Proposta da Administração, valor esse que inclui, na forma determinada pela CVM, a melhor estimativa do valor dos encargos incidentes sobre o componente de longo prazo baseado em ações, estando tais encargos sujeitos a variação no futuro em função da oscilação do preço de mercado das ações da Companhia ou de eventual alteração das alíquotas legalmente aplicáveis.

(4) Registrar a instalação do Conselho Fiscal, solicitada por acionistas titulares de ações representativas de mais de 2% do total do capital social da Companhia, e aprovar, por maioria dos acionistas presentes, tendo sido computados 1.133.126.803 de votos a favor, 7.205.209 de votos contrários; e 221.815.537 abstenções, a eleição das pessoas a seguir para comporem o Conselho Fiscal da Companhia, para mandato até a Assembleia Geral Ordinária que aprovar as demonstrações financeiras do exercício a se encerrar em 31/12/2020: **(i) ÂNGELA APARECIDA SEIXAS**, brasileira, contadora, portadora da Cédula de identidade RG nº 11.769.058-2 SSP/SP, e inscrita no CPF/MF sob o nº 011.500.868-31, como membro efetivo do Conselho Fiscal; e **GILBERTO LOURENÇO DA APARECIDA**, brasileiro, economista, portador da Cédula de Identidade RG nº 02681429850 DETRAN/DF, e inscrito no CPF/MF

Registrou-se a apresentação, pelos eleitos para o Conselho Fiscal, dos documentos comprobatórios do atendimento das condições prévias de elegibilidade previstas no art. 162 da Lei 6.404/76.

Além dos candidatos ora eleitos, os seguintes candidatos ao Conselho Fiscal não receberam votos suficientes para serem eleitos: com 5 votos a favor, a Sra. Lucy Azevedo Marinho, como candidata a membro efetivo, e Sr. José Diones Carlos Lima, como candidato a membro suplente.

Aprovar também, por maioria dos acionistas presentes, tendo sido computados 1.136.479.453 de votos a favor, 672.276 de votos contrários; e 224.995.820 abstenções, a fixação da remuneração global anual dos membros do Conselho Fiscal para o corrente exercício, no valor de até R\$ 497.000,00.

(c) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.201.162.264 de votos a favor, e 191.965.427 abstenções, a alteração do prazo máximo para exercício do cargo de membro do Comitê de Auditoria que também seja membro do Conselho de Administração;

(d) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.205.004.043 de votos a favor, e 188.123.648 abstenções, a exclusão da disposição transitória prevista no

artigo 79, dado que não restaram membros no Comitê de Auditoria que atendam à disposição transitória;

(e) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.205.004.043 de votos a favor, e 188.123.648 abstenções, outros ajustes de redação, referência cruzada e renumeração; e

(f) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 1.205.004.043 de votos a favor, e 188.123.648 abstenções, a consolidação de tais propostas de alteração estatutária no Estatuto Social vigente.
