PRESENÇA: Presentes, em Assembleia Geral Ordinária, acionistas representando mais de 67,29% (sessenta e sete vírgula vinte e nove por cento) do capital social votante e total da Companhia, e, em Assembleia Geral Extraordinária, acionistas representando mais de 66,74% (sessenta e seis vírgula setenta e quatro por cento) do capital social votante e total da Companhia, conforme se verifica (i) pelas presenças registradas por meio da plataforma eletrônica disponibilizada pela Companhia, nos termos da ICVM 481, e (ii) pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia ou diretamente pela Companhia, nos termos da regulamentação da CVM. Em razão do quórum verificado, o Presidente deu por instalada a Assembleia Geral Ordinária e a Assembleia Geral Extraordinária. Presentes, ainda, integrantes da Administração da Companhia e o Sr. Flávio Serpejante Peppe, representante da Ernst & Young Auditores Independentes S.S., além do Coordenador do Comitê de Auditoria e de membros do Conselho Fiscal.

ORDEM DO DIA: I – Em Assembleia Geral Ordinária: (1) Deliberar sobre as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em

31/12/2021; (2) Deliberar sobre a destinação do resultado do exercício social encerrado em 31/12/2021; (3) Deliberar sobre a remuneração global dos administradores para o exercício de 2022, conforme detalhado na Proposta da Administração; (4) Deliberar sobre a eleição de membro do Conselho de Administração da Companhia, nomeado pelo Conselho de Administração em reunião realizada em 31/5/2021 em face da renúncia de Conselheiro, nos termos do art. 150 da Lei das S.A., para cumprimento do mandato em curso com término na Assembleia Geral Ordinária de 2023, conforme Proposta da Administração; (5) Na hipótese de haver pedido válido de instalação do Conselho Fiscal, eleger os respectivos membros, conforme indicados na Proposta da Administração; e (6) Na hipótese de haver eleição do Conselho Fiscal, fixar a sua remuneração, conforme Proposta da Administração. **II – Em Assembleia Geral Extraordinária:** (1) Deliberar sobre alterações do Estatuto Social da Companhia, conforme detalhadas na Proposta da Administração; (2) Consolidar o Estatuto Social da Companhia para refletir as alterações, conforme detalhadas na Proposta da Administração; e (3) Deliberar sobre propostas de alteração no Plano de Concessão de Ações da Companhia, conforme detalhadas na Proposta da Administração.

DELIBERAÇÕES: Dispensada a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, consoante o parágrafo 4º do art. 21-W da ICVM 481, foram tomadas, com a abstenção dos legalmente impedidos, as seguintes deliberações, registrando-se a lavratura da presente ata na forma de sumário e havendo-se autorizado a sua publicação com a omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei das S.A.:

I – Em Assembleia Geral Ordinária:

(1) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.500.081.593 votos a favor, 22.553.926 votos contrários; e 501.603.663 abstenções; e sem reservas, as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2021, acompanhadas das Notas Explicativas, do Parecer da Ernst & Young Auditores Independentes S.S., do Relatório do Comitê de Auditoria e do Parecer do Conselho Fiscal, registrada a abstenção de voto dos administradores nesse item.

(2) Aprovar, por maioria dos acionistas presentes, tendo sido computados 4.013.141.838 votos a favor, 7.694.585 votos contrários; e 3.402.759 abstenções proposta de destinação do resultado do exercício social encerrado em 31/12/2021, nos seguintes termos: (a) distribuição integral do lucro líquido societário do exercício, no valor de R\$ 4.717.096.997,00, aos acionistas da Companhia, dos quais R\$ 3.927.801.919,00 foram pagos, a título de dividendos ou de juros sobre capital próprio, durante o exercício de 2021, e o saldo restante de R\$789.295.078,00 pago a título de dividendos em 8 de abril de 2022, com base na posição acionária de 24 de março de 2022; e (b) destinação dos demais valores registrados diretamente na rubrica de lucros acumulados durante o exercício no montante de R\$ 41.883.445,56 para a reserva estatutária referida no Art. 56, §1º, (ii) do Estatuto Social.

(3) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.850.619.051 votos a favor, 136.757.082 votos contrários; e 36.863.049 abstenções, a fixação da remuneração global anual dos administradores da Companhia, para o corrente exercício, no valor de até R\$ 119.527.976,91, nos termos da Proposta da Administração.

(4) Aprovar, por maioria dos acionistas presentes, tendo sido computados 4.019.329.623 votos a favor, 365.700 votos contrários; e 4.543.859 abstenções, a eleição, para cumprir mandato unificado com os demais conselheiros até a Assembleia Geral Ordinária que aprovar as demonstrações financeiras do exercício a se encerrar em 31/12/2022, como **Membro Independente do Conselho de Administração da Companhia**, conforme definido no Estatuto Social da Companhia, do Sr. **JOÃO VITOR NAZARETH MENIN TEIXEIRA DE SOUZA**, brasileiro, casado, engenheiro civil, portador da Cédula de Identidade RG nº MG-11.657.757, inscrito no CPF sob o nº 013.436.666-27, domiciliado na cidade de São Paulo, Estado de São Paulo, com escritório na Praça Antonio Prado, nº 48, 7º andar, Centro, o qual foi nomeado pelo Conselho de Administração em reunião realizada em 31/5/2021 em face da renúncia de um Conselheiro, nos termos do art. 150 da Lei das S.A., conforme Proposta da Administração, tendo sido atestado que, conforme declarações por ele fornecidas, o Membro Independente do Conselho de Administração ora eleito enquadra-se nos critérios de independência estabelecidos no Regulamento do Novo Mercado. O membro do Conselho de Administração ora eleito tomará posse no seu cargo mediante apresentação: (i) do respectivo termo de posse, lavrado em livro próprio, contendo as declarações em atendimento à lei e à regulamentação em vigor; (ii) da declaração de desimpedimento, para os fins do Artigo 147 da Lei nº 6.404/76 e do Artigo 2º da Instrução CVM nº 367/02; e (iii) da declaração dos valores mobiliários por ele eventualmente detidos de emissão da Companhia e de suas sociedades controladas ou do mesmo grupo, nos termos do Artigo 157 da Lei nº 6.404/76.

(5) Registrar a instalação do Conselho Fiscal, solicitada por acionistas titulares de ações representativas de mais de 65,17% (sessenta e cinco vírgula dezessete por cento) do total do capital social da Companhia, e aprovar, por maioria dos acionistas presentes, tendo sido computados 3.989.536.414 votos a favor, 30.082.899 votos contrários; e 4.619.869 abstenções, a eleição das pessoas a seguir para comporem o Conselho Fiscal da Companhia, para mandato até a Assembleia Geral Ordinária que aprovar as demonstrações financeiras do exercício a se encerrar em 31/12/2022: **(i) ANGELA APARECIDA SEIXAS**, brasileira, contadora, portadora da Cédula de identidade RG nº 11.769.058-2 SSP/SP, e inscrita no CPF/ME sob o nº 011.500.868-31, como **membro efetivo**; e **GILBERTO LOURENÇO DA APARECIDA**, brasileiro, economista, portador da Cédula de Identidade RG nº 02681429850 DETRAN/DF, e inscrito no CPF/ME sob o nº 377.114.076-53, como seu respectivo **membro suplente**; **(ii) ANDRÉ COJI**, brasileiro, casado, administrador de empresas, portador da Cédula de Identidade RG nº 8.782.472, e inscrito no CPF/ME sob o nº 051.271.338-30, como **membro efetivo**; e **MARIA PAULA SOARES ARANHA**, brasileira, solteira, administradora de empresas, portadora da Cédula de Identidade RG nº 7.779.372-9 e inscrita no CPF/ME sob o nº 035.859.048-58, como seu respectivo **membro suplente**; e **(iii) MARIA ELENA CARDOSO FIGUEIRA**, brasileira, divorciada, economista, portadora da Cédula de Identidade RG nº 06999925-8 Detran-RJ e inscrita no CPF/ME sob o nº 013.908.247-64, como **membro efetivo**; e **ESTELA MARIS VIERA DE SOUZA**, brasileira, divorciada, administradora de empresas, portadora da Cédula de Identidade RG nº 39.020.442-0 e inscrita no CPF/ME sob o nº 430.340.800-00, como seu respectivo **membro suplente** todos residentes e domiciliados no município de São Paulo, Estado de São Paulo, com endereço na Praça Antonio Prado, 48, 7º andar, Centro, São Paulo – SP. Registrou-se a apresentação, pelos eleitos para o Conselho Fiscal, dos documentos comprobatórios do atendimento das condições prévias de elegibilidade previstas no art. 162 da Lei 6.404/76.

(6) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.934.910.262 votos a favor, 5.465.499 votos contrários; e 83.863.421 abstenções, a fixação da remuneração dos

membros do Conselho Fiscal da Companhia, para o corrente exercício, no valor de até R\$ 477.189,90 nos termos da Proposta da Administração.

(1.a) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, o Bloco A de alterações estatutárias, qual seja – objeto social: alterar o objeto social da Companhia, constante do Art. 3º, para inclusão, de forma mais específica, das atividades associadas às licitações públicas e privadas, já exercidas pela Companhia, conforme autorização da CVM pelo Ofício 222/2011-DO-DOP, de 14 de julho de 2011;

(1.b) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, o Bloco B de alterações estatutárias, qual seja: – capital social: alterar a expressão do capital social da Companhia, constante do Art. 5º, para refletir o cancelamento de 27 milhões de ações mantidas em tesouraria, conforme aprovado pelo Conselho de Administração em 17/3/2022;

(1.c) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, o Bloco C de alterações estatutárias, qual seja – ajustes de atribuições: (c.1) alterar a redação do Art. 16, (i) para aumentar o valor mínimo das alienações, ou contribuições ao capital social de outras entidades, de ativos da Companhia que estariam sujeitas à deliberação da Assembleia, tendo em vista a alteração do Art. 122, X, da Lei 6.404/76 (Lei das S.A.) pela Lei 14.195, de 26 de agosto de 2021, que estabeleceu este tipo de competência para as Assembleias, anteriormente não previstas pela Lei; (c.2) inserir a alínea (v) no Art. 29, para esclarecer que a alçada do Conselho de Administração com relação à deliberação sobre celebração de transações entre partes relacionadas é estabelecida pela Política de Transações Entre Partes Relacionadas e Demais Situações de Potencial Conflito de Interesses, em linha com as melhores práticas previstas pelo item 5.3.1 do Informe do Código Brasileiro de Governança Corporativa (Instrução CVM nº 480/2009); e (c.3) ajustar a redação das alíneas (j) e (k) do Parágrafo Único do Art. 49 para melhor refletir as atribuições já desempenhadas pelo Comitê de Governança e Indicação;

(1.d) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, o Bloco D de alterações estatutárias, qual seja – ajustes nos requisitos para composição do Conselho de Administração: (d.1) alterar o §9º do Art. 22 para alinhá-lo ao disposto na Instrução CVM nº 461/07, observado o §6º do referido artigo; e (d.2) alterar o §13 do Art. 22 para esclarecer as situações que devem ensejar no término antecipado do mandato de Conselheiros eleitos, conforme compromissos assumidos no momento da posse;

(1.e) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, o Bloco E de alterações estatutárias, qual seja – ajuste no prazo de mandato da Diretoria: alterar o Art. 32, caput, para permitir que o mandato dos membros seja de até 2 anos, de modo que, em caso de

eleição de Diretor ou Vice-Presidente no curso de um mandato já em andamento da Diretoria, seja possível eventual unificação dos prazos de mandato, caso o Conselho de Administração avalie ser pertinente;

(1.f) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.976.469 votos a favor, 365.700 votos contrários; e 3.949.759 abstenções, o Bloco F de alterações estatutárias, qual seja – representação da Companhia: incluir a alínea (d) no Art. 43, para prever que dois Diretores possam representar a Companhia, sem a necessidade do Presidente e/ou de um Vice-Presidente em conjunto, considerando o aumento do número de Diretores que poderão compor a Diretoria da Companhia, nos termos da redação aprovada para o Art. 32, caput, pela Assembleia Geral Extraordinária de 12/5/2021; e;

(1.g) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, o Bloco G de alterações estatutárias, qual seja – outros ajustes: (g.1) alterar a referência à Instrução CVM nº 358/2002, substituída pela Resolução CVM nº 44/2021; (g.2) outros ajustes de redação, referência cruzada e renumeração.

(2) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.986.998.469 votos a favor, 365.700 votos contrários; e 3.927.759 abstenções, a consolidação do Estatuto Social da Companhia, para refletir as alterações acima indicadas, conforme Anexo I à presente ata (“**Anexo I**”).

(3) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.661.457.358 votos a favor, 325.906.811 votos contrários; e 3.927.759 abstenções, as alterações no Plano de Concessão de Ações da Companhia, nos termos da Proposta da Administração.
