1. **Data, Hora e Local:** Realizada em 09 de abril de 2021, às 11 horas, de modo inteiramente digital, conforme Instrução da Comissão de Valores Mobiliários ("CVM") nº 481, de 17 de dezembro de 2009, conforme alterada ("Instrução CVM 481").
2. **Convocação:** O Edital de Convocação foi publicado, em primeira convocação, nos jornais "Diário Oficial do Estado do Paraná", nas edições dos dias 25, 26 e 29 de março de 2021, nas páginas 40, 50 e 68, respectivamente, e no jornal "Bem Paraná", nas edições dos dias 25, 26 e 29 de março, nas páginas 10, 20 e 21, respectivamente, nos termos do artigo 124 da Lei nº 6.404, de 15 de dezembro de 1976, conforme alterações ("Lei das Sociedades por Ações").
3. **Presenças:** Presentes à Assembleia Geral Extraordinária ("AGE") acionistas representando 53,95% do capital social da Companhia, conforme assinaturas constantes do Livro de Presença de Acionistas e Anexo I desta ata. Presente a Sra. Maria Rita Carvalho Drummond, representando o Sr. Rubens Ometto Silveira Mello, como Presidente e membro do Conselho de Administração da Companhia, bem como o representante da Administração, Sr. Ricardo Lewin, Vice-Presidente Financeiro e de Relações com Investidores.
4. **Mesa:** Os trabalhos foram presididos pela Sra. Maria Rita Carvalho Drummond e secretariado pela Sra. Beatriz Primon de Orneles Cereza.
5. **Publicações, Divulgações e Leitura dos Documentos:** Todos os documentos relacionados às matérias a serem deliberadas, conforme previsto Instrução CVM 481, foram disponibilizados aos acionistas na sede da Companhia e/ou na internet (www.ri.rumolog.com, www.cvm.gov.br e www.b3.com.br), razão pela qual foi dispensada a leitura dos documentos relacionados às matérias a serem deliberadas nesta AGE.
6. **Ordem do dia:** Discutir e deliberar sobre a seguinte matéria: alteração e consolidação do Estatuto Social da Companhia.
7. **Ausência de Quórum Qualificado e Não Instalação da Assembleia, em Primeira Convocação.** A AGE convocada para esta data para deliberar as propostas de alteração do

Estatuto Social da Companhia – conforme a Ordem do Dia constante do Edital de Convocação – não foi instalada, tendo em vista não ter sido atingido o quórum mínimo legal de 2/3 (dois terços) para a sua instalação em primeira convocação, nos termos do artigo 135 da Lei das Sociedades por Ações.

A administração da Companhia promoverá a segunda convocação da AGE nos termos do artigo 124, inciso II, da Lei das Sociedades por Ações, observado que o Edital de Segunda Convocação será publicado no dia 12 de abril de 2021. Esclarece-se que, em segunda convocação, a referida AGE será instalada com a presença de qualquer número de acionistas, que deliberarão, pela maioria de votos dos acionistas presentes, sobre as matérias constantes da ordem do dia indicadas no Edital de Convocação.

8. Encerramento: Não havendo nada mais a tratar, o Presidente declarou a AGE como não instalada, suspendeu os trabalhos para a lavratura da presente ata, na forma de sumário dos fatos ocorridos, conforme faculta o artigo 130, § 1º, da Lei das S.A, e autorizada a sua publicação com a omissão das assinaturas dos acionistas, nos termos do artigo 130, §2º, da Lei das S.A., que lida e achada conforme, foi assinada por todos os presentes.
