DATA, HORA E LOCAL: Realizada em 25 de janeiro de 2019, às 10:00 horas, na sede da Companhia, localizada na Praça Quinze de Novembro, nº 20, 6º andar, Salas 601 e 602, Centro, na Cidade e Estado do Rio de Janeiro.

PRESENCAS: Acionistas representando 75,18% do capital social da Companhia com direito a voto, conforme se verifica pelas assinaturas constantes do Livro de Presença de Acionistas da Companhia.

CONVOCAÇÃO E PUBLICAÇÕES: Editais de Convocação publicados no Diário Oficial do Estado do Rio de Janeiro nas edições dos dias 10, 11 e 14 de janeiro de 2019, nas páginas 6, 3 e 5, respectivamente, e no jornal Valor Econômico nas edições dos dias 10, 11 e 12, 13 e 14 de janeiro de 2019, nas páginas B7, B5 e B5, respectivamente.

MESA: Assumiu a presidência dos trabalhos a Srta. Natalia Silva de Lima, representante da acionista Companhia Energética de Minas Gerais – CEMIG, que convidou a Srta. Bárbara da Cunha Xavier, representante da acionista ISA Investimentos e Participações do Brasil S.A., para secretariá-la. Presente, também, o Sr. José Aloise Ragone Filho, Diretor de Negócios e Gestão de Participações da Companhia como representante da Administração.

ORDEM DO DIA: Deliberar sobre a ratificação do exercício do direito de preferência e aprovação da celebração do contrato de compra e venda para aquisição das ações da Companhia Transirapé de Transmissão, da Companhia Transleste de Transmissão e da Companhia Transudeste de Transmissão, em conjunto denominadas “Transmineiras”, objeto do Lote M do Leilão Eletrobras nº 01/2018, homologado para a TAESA pela Comissão de Alienação do Leilão em 26 de novembro de 2018, e consequentemente, a transferência das referidas ações para a Companhia após o cumprimento das condições precedentes previstas no contrato, nos termos da alínea “o”, do § primeiro do artigo 12 do Estatuto Social da Companhia.

DELIBERAÇÕES: Instalada a assembleia, os acionistas presentes dispensaram a leitura da proposta objeto da ordem do dia da reunião e, após o exame, discussão e votação da matéria, deliberaram, por unanimidade de votos, tendo sido computados 98,86% de votos a favor (representados por 439.036.156 ações ordinárias) e 1,14% de abstenção (representados por 5.069.000 ações ordinárias), pela ratificação do exercício do direito de preferência e celebração do Contrato de Compra e Venda e Outras Avenças, para a aquisição das ações da Companhia Transirapé de Transmissão, da Companhia Transleste de Transmissão e da Companhia Transudeste de Transmissão, em conjunto denominadas “Transmineiras”, objeto do lote M do

Leilão Eletrobras nº 01/2018, homologado para a TAESA pela Comissão de Alienação do Leilão de 26 de novembro de 2018, e, consequentemente, a transferência das referidas ações para a Companhia após o cumprimento das condições precedentes previstas no contrato. Por fim, fica a administração da companhia autorizada a tomar todas as medidas e realizar todos os procedimentos necessários à conclusão da transação.

ENCERRAMENTO: Nada mais havendo a ser tratado, foi encerrada a assembleia, da qual se lavrou a presente ata que, lida e achada conforme, foi por todos aprovada e assinada.
